

# EASTERN COLLEGE INTERNATIONAL GRADUATE IMMIGRATION PATHWAYS



Eastern College international graduates do not qualify for the Post-Graduation Work Permit (PGWP). However, there are alternative immigration pathways that Eastern College international graduates may be eligible for. Kindly see below options and resources for more information:

## 1. NEW BRUNSWICK PRIVATE CAREER COLLEGE GRADUATE PILOT PROGRAM

International students who graduate from Eastern College in New Brunswick in eligible programs can apply to this immigration stream for their work permit. This will allow them to continue to live and work in New Brunswick as they wait for permanent residency. You must have a full-time permanent job offer from a New Brunswick employer in a job category that corresponds with your recent field of study within 90 days of graduating

## 2. NOVA SCOTIA INTERNATIONAL GRADUATES IN DEMAND:

Eastern College International graduates in specific Healthcare programs are eligible to apply for this pathway. This will allow them to continue to live and work in Nova Scotia as they wait for permanent residency. You must have a full-time permanent job offer from a Nova Scotia employer in a job category that corresponds with your recent field of study within 90 days of graduating.

## 3. ATLANTIC IMMIGRATION PROGRAM (AIP):

The AIP is a federal pathway to permanent residency for skilled workers and international graduates who wish to work and live in one of Canada's Atlantic provinces, including Nova Scotia and New Brunswick. Priority sectors are HEALTHCARE, EDUCATION and CONSTRUCTION, so certain Eastern College programs are eligible. You must receive a job offer from a designated employer in Atlantic Canada to participate in the program, and have a certain amount of prior work experience to qualify.

## 4. SKILLED WORKER STREAM

Both New Brunswick and Nova Scotia have a Skilled Worker Stream, which offers a pathway towards permanent residence for foreign nationals planning to settle in the province. Priority sectors are HEALTHCARE, EDUCATION and CONSTRUCTION so graduates of specific programs may qualify. Requirements include a job offer for a full-time, non-seasonal position with an eligible New Brunswick or Nova Scotia employer. Please see below for more information
